**KEY OPERATING DATA OF 2021 FOURTH QUARTER**

This announcement is made pursuant to the inside information provisions under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong) and Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited.

The board of directors (the “**Board**”) of China Suntien Green Energy Corporation Limited (the “**Company**”) hereby announces the key operating data of 2021 fourth quarter of the Company and its subsidiaries (collectively, the “**Group**”).

**NEW ENERGY BUSINESS SEGMENT**

According to the Company’s preliminary statistics, the power generation of the Group on a consolidated basis for the 2021 fourth quarter amounted to 4,170,542.55 MWh, representing an increase of 25.40% over the corresponding period of 2020; the on-grid power generation amounted to 3,988,895.65 MWh, representing an increase of 27.53% over the corresponding period of 2020. As of 31 December 2021, the accumulated power generation amounted to 13,736,084.48 MWh, representing an increase of 36.67% over the corresponding period of 2020; the accumulated on-grid power generation amounted to 12,830,326.25 MWh, representing an increase of 36.52% over the corresponding period of 2020. From January to December 2021, the average on-grid tariff (tax exclusive) of the Company was RMB0.48/KWh, representing an increase of 0.94% over the corresponding period of 2020; the Company’s transacted electricity volume in the electricity market amounted to 1,302,893.90 MWh, the proportion of transacted electricity volume in the electricity market amounted to 10.15%, representing a decrease of 2.95 percentage points over the corresponding period of 2020.

According to the Company's preliminary statistics, the sales volume of gas of the Group on a consolidated basis for the 2021 fourth quarter amounted to 1,092,076,500 cubic meters, representing a decrease of 3.39% over the corresponding period of 2020. As of 31 December 2021, the accumulated sales volume of gas amounted to 3,807,903,600 cubic meters, representing an increase of 8.03% over the corresponding period of 2020.
