KEY OPERATING DATA OF AUGUST 2024

This announcement is made by China Suntien Green Energy Corporation Limited (the “**Company**”) pursuant to the inside information provisions under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong) and Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited.

According to the Company’s preliminary statistics, the power generation of the Company and its subsidiaries (collectively, the “**Group**”) on a consolidated basis for August 2024 amounted to 635,317.60 MWh, representing a year-on-year increase of 0.42%. As at 31 August 2024, the accumulated power generation amounted to 8,935,725.40 MWh, representing a year-on-year decrease of 5.55%.

According to the Company's preliminary statistics, the transmission/sales volume of gas of the Group on a consolidated basis for August 2024 amounted to 397.0583 million cubic meters, representing a year-on-year increase of 40.96%, of which, the sales volume of gas amounted to 332.5555 million cubic meters, representing a year-on-year increase of 44.22%; the volume of gas transported by the Group for its clients amounted to 64.5029 million cubic meters, representing a year-on-year increase of 26.27%. As at 31 August 2024, the accumulated transmission/sales volume of gas amounted to 4,166.5860 million cubic meters, representing a year-on-year increase of 41.33%, of which, sales volume of gas amounted to 3,641.2158 million cubic meters, representing a year-on-year increase of 45.05%, the volume of gas transported by the Group for its clients amounted to 525.3701 million cubic meters, representing a year-on-year increase of 19.99%.
