The board of directors (the "Board") of China Suntien Green Energy Corporation Limited (the "Company") hereby announces the key operating data of 2024 second quarter of the Company and its subsidiaries (collectively, the "Group").

NEW ENERGY BUSINESS SEGMENT

According to the Company's preliminary statistics, the power generation of the Group on a consolidated basis for the 2024 second quarter amounted to 3,413,641.84 MWh, representing a decrease of 7.91% over the corresponding period of 2023; the on-grid power generation amounted to 3,333,365.17 MWh, representing a decrease of 8.03% over the corresponding period of 2023. As of 30 June 2024, the accumulated power generation amounted to 7,530,913.65 MWh, representing a decrease of 3.61%; the accumulated on-grid power generation amounted to 7,355,583.20 MWh, representing a decrease of 3.73%. From January to June 2024, the average on-grid tariff (tax exclusive) of the Group was RMB0.44/KWh, flat as that for the same period last year; while the proportion of transacted electricity volume in the electricity market of the Group amounted to 2,620,061.00 MWh, while the proportion of transacted electricity volume amounted to 35.62%, representing a decrease of 1.70 percentage point over the corresponding period of 2023.

As of 30 June 2024, the accumulated transmission/sales volume of gas amounted to 3,393.4265 million cubic meters, representing an increase of 42.27% over the corresponding period of 2023, of which, the sales volume of gas amounted to 3,017.0068 million cubic meters, representing an increase of 46.50% over the corresponding period of 2023, while the volume of gas transported by the Group for its clients amounted to 376.4196 million cubic meters, representing an increase of 15.58% over the corresponding period of 2023.
