OPERATING DATA OF 2017 FIRST QUARTER

This announcement is made pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited and the Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Cap. 571, Laws of Hong Kong).

The board of directors (the “**Board**”) of China Suntien Green Energy Corporation Limited (the “**Company**”) announced that, according to the Company’s preliminary statistics, total generation power of the Company and its subsidiaries (collectively, the “**Group**”) on a consolidated basis for the 2017 first quarter amounted to 1,792,128.91MWh, representing an increase of 50.06% over the same period in 2016. Among which, the gross wind power generation was 1,773,889.76MWh, representing an increase of 49.85% over the same period in 2016. The solar power generation was 18,239.15MWh, representing an increase of 73.80% over the same period in 2016. The sale volume of gas of the Group on a consolidated basis for the 2017 first quarter amounted to 525,960,500 cubic meters, representing an increase of 44.72% over the same period in 2016. Among which, the wholesale segment amounted to 352,587,100 cubic meters, representing an increase of 27.60%; the retail segment amounted to 155,571,700 cubic meters, representing an increase of 129.29%; and the CNG/LNG segment amounted to 17,801,700 cubic meters, representing a decrease of 7.67%.
