OPERATING DATA OF 2018 FIRST QUARTER

This announcement is made pursuant to the inside information provisions under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong) and Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited.

The board of directors (the “**Board**”) of China Suntien Green Energy Corporation Limited (the “**Company**”) announces that, according to the Company’s preliminary statistics, total power generation of the Company and its subsidiaries (collectively, the “**Group**”) on a consolidated basis for the 2018 first quarter amounted to approximately 2,509,371.62 MWh, representing an increase of 40.02% over the corresponding period of 2017, comprising the gross wind power generation of approximately 2,481,172.72MWh, representing an increase of 39.78% over the corresponding period of 2017 and the solar power generation of approximately 28,198.90MWh, representing an increase of 54.61% over the corresponding period of 2017. The sales volume of gas of the Group on a consolidated basis for the 2018 first quarter amounted to approximately 868,562,500 cubic meters, representing an increase of 65.14% over the corresponding period of 2017, comprising the wholesale segment of approximately 627,684,600 cubic meters, representing an increase of 78.02% over the corresponding period of 2017, the retail segment of approximately 218,676,000 cubic meters, representing an increase of 40.56% over the corresponding period of 2017, and the CNG/LNG segment of approximately 22,201,900 cubic meters, representing an increase of 24.72% over the corresponding period of 2017.

Details of the gross power generation and the sales volume of gas of the Group for the three months ended 31 March 2018 and 2017 are as follow:
