OPERATING DATA OF 2018 FOURTH QUARTER

This announcement is made pursuant to the inside information provisions under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong) and Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited.

The board of directors (the “**Board**”) of China Suntien Green Energy Corporation Limited (the “**Company**”) announces that, according to the Company’s preliminary statistics, total power generation of the Company and its subsidiaries (collectively, the “**Group**”) on a consolidated basis for the 2018 fourth quarter amounted to 2,332,302.16MWh, representing an increase of 5.08% over the corresponding period in 2017. In particular, the gross wind power generation was 2,295,511.81MWh, representing an increase of 4.45% over the corresponding period in 2017; the solar power generation was 36,790.34MWh, representing an increase of 67.63% over the corresponding period in 2017. The sales volume of gas of the Group on a consolidated basis for the 2018 fourth quarter amounted to 918,569,000 cubic meters, representing an increase of 30.20% over the corresponding period in 2017. In particular, the wholesale segment amounted to 590,383,100 cubic meters, representing an increase of 31.64% over the corresponding period in 2017; the retail segment amounted to 296,291,000 cubic meters, representing an increase of 31.31% over the corresponding period in 2017; and the CNG/LNG segment amounted to 31,894,800 cubic meters, representing an increase of 1.64% over the corresponding period in 2017.
