OPERATING DATA OF 2019 FIRST QUARTER

This announcement is made pursuant to the inside information provisions under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong) and Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited.

The board of directors (the “**Board**”) of China Suntien Green Energy Corporation Limited (the “**Company**”) announces that, according to the Company’s preliminary statistics, total power generation of the Company and its subsidiaries (collectively, the “**Group**”) on a consolidated basis for the 2019 first quarter amounted to 2,666,624.85 MWh, representing an increase of 6.27% over the corresponding period of 2018, comprising the gross wind power generation of 2,628,155.27MWh, representing an increase of 5.92% over the corresponding period of 2018 and the solar power generation of 38,469.59MWh, representing an increase of 36.42% over the corresponding period of 2018. The sales volume of gas of the Group on a consolidated basis for the 2019 first quarter amounted to 1,173,424,500 cubic meters, representing an increase of 35.10% over the corresponding period of 2018, comprising the wholesale segment of 846,608,800 cubic meters, representing an increase of 34.88% over the corresponding period of 2018, the retail segment of 300,791,200 cubic meters, representing an increase of 37.55% over the corresponding period of 2018, and the CNG/LNG segment of 26,024,400 cubic meters, representing an increase of 17.22% over the corresponding period of 2018.

Details of the gross power generation and the sales volume of gas of the Group for the three months ended 31 March 2019 and 2018 are as follow:
