The board of directors (the "Board") of China Suntien Green Energy Corporation Limited (the "Company") announces that, according to the Company's preliminary statistics, total power generation of the Company and its subsidiaries (collectively, the "Group") on a consolidated basis for the 2019 fourth quarter amounted to 2,715,166.00MWh, representing an increase of 16.42% over the corresponding period in 2018. In particular, the gross wind power generation was 2,681,138.25MWh, representing an increase of 16.80% over the corresponding period in 2018; the solar power generation was 34,027.75MWh, representing a decrease of 7.51% over the corresponding period in 2018. The sales volume of gas of the Group on a consolidated basis for the 2019 fourth quarter amounted to 1,091,929,200 cubic meters, representing an increase of 18.87% over the corresponding period in 2018. In particular, the wholesale segment amounted to 695,406,300 cubic meters, representing an increase of 17.79% over the corresponding period in 2018; the retail segment amounted to 369,326,500 cubic meters, representing an increase of 24.65% over the corresponding period in 2018; and the CNG/LNG segment amounted to 27,196,400 cubic meters, representing a decrease of 14.73% over the corresponding period in 2018.
